### EXPERIENCE

I am a Consultant Clinical Psychologist in independent clinical practice. In addition to providing psychological therapy to adults including young adults, I regularly prepare expert witness reports on adults within a range of legal proceedings including family, divorce, criminal, employment tribunal and personal injury. I frequently give evidence in court.

My previous appointment was with East London NHS Foundation Trust as Head of Psychology for the City & Hackney Directorate. I was the professional head of all psychologists working with adults in general mental health services across a catchment area coterminous with the City of London and the London Borough of Hackney. This involved overseeing clinical, professional and strategic matters relevant to all service activity.

Prior to that I was at the Tavistock & Portman NHS Foundation Trust and the University of Essex as Honorary Consultant Clinical Psychologist in the Adult Department, and Senior Clinical Research Fellow and Associate Director of Research (Psychotherapy Outcomes Research Programme) within the Psychotherapy Evaluation Research Unit. I specialised in the assessment and treatment of adults with the full range of mental health problems. I was also an expert member of the Camden & Islington Community Local Research Ethics Committee.

Previously, I was Consultant Clinical Psychologist and Head of Adult Psychology Services for South Westminster and the Gordon Hospital, London SW1, part of Central and North West London Mental Health NHS Trust. I provided for the assessment and treatment of a wide range of mental health problems, including personality disorders and severe mental disturbance.

I have been involved as a therapist in a clinical research trial, funded the Medical Research Council and involving Imperial College London School of Medicine and University of Glasgow, examining treatment outcomes for offenders with a diagnosis of anti-social personality disorder.
